- 2 working days' notice must be given for a cancellation
- Full payment is required for any booking that is cancelled with less than 2 working days' notice
- Bookings are confirmed be email. Please advise if you do not have access to email. Your booking is not confirmed until you receive the confirmation email. Invoices are emailed to the person making the booking and payment unless requested otherwise.
- Payment is required in full prior to delivery unless discussed otherwise.
- For all weekend bookings, we deliver on the Friday and picked up the following Monday, unless discussed otherwise.
- All pre-packaged orders require 2 weeks' notice
- The supplies provided with the hire are complimentary and no refund will be given on unused portions, even is extra has been ordered
- It is a condition of hire that any damages sustained to the machinery or equipment will be paid the person who has made the booking
