We have also introduced a media fee of \$50 that is required to photograph at this event this must be paid on approval of application with a current copy of your public liability.

(Media passes are separate to show entrant insurance.)

Important information for freelance journalists, photographers or production/companies:

In order to gain accreditation you must email a letter (to mariehutchison2009@gmail.com) from your editor/producer/employer, on an official company letterhead confirming your assignment to cover the National Capital Horse Show. Please note if you are a freelance journalist, photographer or production/company and do not upload this information, your application will be considered incomplete and will not be processed. The letter must include:

- The type, extent and focus of the planned coverage
- The primary market, circulation size and target audience of the outlet
- For online media: Information on publication frequency, average number of daily hits and visitor statistics (unique visitors and page views)
- For photographers: the intended use of photographs taken e.g. for sale on business website for exhibitors to purchase
- All photographers will be an allocated areas

CONDITIONS OF PARTICIPANT - MEDIA (CORPORATION)

1.

partaking in media activities at the National Capital Horse Show organised by Arabian Riders & Breeders (ACT and Southern NSW) Inc., the Participant will adhere to these Conditions of Participant. The Participant acknowledges that the word 'Participant' includes and extends to all employees, agents, contractors and assigns of the Participant in whatever capacity whilst attending the Showground as aforesaid.

1. These Conditions of Participant and the Event Manual shall constitute the whole agreement between the parties.
2. The Participant acknowledges that they will attend the Showground and participate in media activities at their own risk.
3. In consideration of the NCHS permitting the Participation, the Participant indemnifies the NCHS against all claims, losses, suits and demands made against or suffered by the NCHS by reason of any act or omission, whether it is negligent or otherwise, by the Participant or persons under their control and includes legal costs associated thereto. The Participant agrees that any act or omission on their part found in any action against the NCHS to be negligent shall be deemed to have been negligence for the purpose of any claim under this indemnity.
4. The Participant acknowledges that the Participation may require the Participant to be located in or be in the vicinity where there could be a risk of personal injury to persons, injury or death to livestock and damage to property. They unconditionally accept responsibility to be fully aware of the possible range of injury and damage and to safeguard themselves, all other persons and livestock.
5. The Participant undertakes to fully and adequately enquire of and to disclose to the NCHS Manager, Communications, or any other person in authority of any circumstance which would or could affect safety to any individual or property whatsoever. The Participant must comply with all directions issued by any person in authority including the use of safety clothing and protective equipment including headwear where applicable at the Participant's cost.
6. The Participant will adhere to the Privacy Laws and unconditionally undertakes to not use any information whatsoever obtained as a result of attendance at the Showground contrary to these Laws. The Participants details will be handled in accordance with the NCHS Privacy Policy.
7. The Participant warrants that they are fit to participate in the required activities whilst on the Showground.
8. The Participant must comply with all reasonable Work Health & Safety requirements of the NCHS and agrees to comply with the requirements of the Work Health and Safety legislation and to attend the scheduled pre-Show safety meeting in order to cooperate and consult with the NCHS to discuss requirements of the Work Health and Safety Act 2011 (NSW) and any regulations under that Act.

9. The Participant must take out and maintain insurance policies to cover the Participants liabilities and responsibilities whilst at the Showground including but not limited to public liability and personal accident.
10. The Participant acknowledges that they must not make any representations to any person or subjects that they are representatives of the NCHS, its agent, contractor or in any way
The Participant hereby acknowledges that as a condition of attending the Showground and related to the NCHS and the Participant must specifically inform any subject that their image will be taken and used for the Participant's personal use.
11. The Participant will not use any of the confidential or privileged information, that they may acquire prior or during their attendance at the Showground in any manner that may injure or cause loss to the NCHS.

The Participant acknowledges that as a condition of being granted the right to participate in the NCHS, all photographs, film, tapes or any other digital media images may only be sold to media organisations for the purpose of publication with the permission of the NCHS. No images may be sold to the general public without the prior consent of the NCHS and the Participant acknowledges that they will be liable to reimburse the NCHS for any monies lost as a result of private sales without the written permission of the NCHS.
