TERMS & CONDITIONS

1. All stall applications must be made in writing & signed with full payment prior to the event to secure their site.
2. The Turangawaewae Regatta committee reserves the right to allocate a “first in first serve” basis on all sites.
3. All sites are allocated by the stall coordinator who reserves the right to restrict to a 3 x 3 m site or extend dependant on space availability. Their decision is final and discussions will not be entered into.
4. Stall holders selling food must ensure they abide by the health & hygiene regulations and may be subject to random health, safety, environmental and food safety inspections.
5. No alcohol or tobacco or illegal substances or related products are to be sold
6. Stallholders may not on-sell their site for any reason
7. Stallholders are responsible for the supply of their own equipment such as tables, chairs and marquees. The Turangawaewae Regatta organisers will not accept liability of any loss or damages to stall holder equipment or goods. The Turangawaewae Regatta organisers are not responsible for the booking or delivery of any hired stall equipment.
8. No parking onsite for any vehicles during the event hours unless approved by the stall holder co-ordinator.
9. Stallholders must be set up and in place by 8.00 am on Wednesday 15 and Thursday 16 March 2017 and/or Saturday 18 March 2017.
10. For safety reasons, stallholders may not bring their vehicle on to the site between 8.30 am – 6 pm during the event on Saturday 18 March 2017.
11. Turangawaewae Regatta is **PARAKORE** which means a zero waste event. All site holders must ensure that all packaging is recyclable. The rubbish bins provided at the event is for the public only therefore **Stallholders are responsible for the disposal of their own rubbish offsite.**
12. No street sellers, buskers or product giveaways are permitted unless previously arranged with the Regatta Organisers. Unauthorised people will be removed from the festival.
13. Failure to comply with any of the terms and conditions will result in a verbal warning, confiscation of goods/services and/or a total shut down of the stall without a refund.
