### WESTERN QUEENSLAND DROUGHT APPEAL CARD - TERMS AND CONDITIONS

**These terms and conditions are legally binding upon use of the card.**

This card is issued by the Western Queensland Drought Committee (WQDC) Inc. for your use, subject to these terms and conditions. The requirements for **YOUR USE OF THIS CARD ARE THAT** you:

- have assessed yourself as eligible to accept the card (see below);
- agree to use this card only for personal purchases (see below);
- understand and accept that transaction types can be monitored by the WQDC Inc. for the purpose of reporting to the Australian Charities and Not-for-profit Commission for audits (see also Item 6 Card Cancellation of Terms and Conditions); and
- understand and accept all Terms and Conditions.<sup>1</sup>

To be eligible to accept this card you must:

- live on a drought affected property within Western Queensland;<sup>2</sup>
- be affected by the drought (financially, physically or emotionally), so that you would otherwise forgo purchasing personal items/services; and
- **be the intended recipient of the card as per the addressed envelope.**

Your use of this card demonstrates that you understand and accept that you:

- will use the funds for **PERSONAL** expenses such as medical (doctors, dentists, pharmacy etc.), education (school fees, school camp fees etc.), groceries, or other personal expenses;
- will spend the funds within Western Queensland;
- **WILL NOT USE THESE FUNDS ON ANY BUSINESS EXPENSES** (such as electricity, telecommunications, registrations, rates, rents, working animal foods, business fuel and tyres etc.) or to pay anything invoiced to a business entity; and
- agree to the WQDC Inc. contacting you from time to time and holding your details on file for this purpose.

If you are uncertain of your eligibility or the meaning of these terms and conditions, please contact the WQDC Inc. for clarification **BEFORE** you use the card.

**IF YOU ARE NOT ELIGIBLE OR CANNOT ACCEPT THE TERMS AND CONDITIONS PLEASE RETURN THE CARD TO THE WQDC INC. PROMPTLY.**

- You must not give your Card to another person.
- *Initial card value:* \$250.00. *Current Card value:* [www.giftcardaccount.com.au](http://www.giftcardaccount.com.au) or 1800 170 359 (check Westpac terms and conditions for charges).
- The card cannot be used to withdraw cash.
- Note the Expiry Date; unused funds revert to WQDC Inc.
- At terminals, select **CREDIT CARD** as type of card.
- It will need to be swiped.<sup>3</sup>
- There is no PIN - you will need to sign. If a PIN is requested - hit OK or ENTER button.
