CHILDREN WILL BE INCLUDED IN THE ANNUAL CONCERT – \$60 (per child) deposit will be added to Term 2 fees. I will advise Hughes Dance Co if my child will not be available before the end of term one & all money will be forfeited if I fail to do so.

PHOTOS/ VIDEOS:

I understand that students will have their photos taken and be filmed at the Concert and on other occasions to use as teaching aids. We will be using some of this footage/ photos as promotional material (on our website/ Face book). No SURNAMES are used for these purposes.
