**Southport Indoor Pistol Club Changes**

The Management Committee of the Southport Indoor Pistol Club Inc passed a resolution on 13 September 2016 to recommend to the members that the club transition its legal status from an incorporated association registered under the *Associations Incorporation Act 1981* (Qld) to a public company limited by guarantee under the *Corporations Act 2001* (Cth) (Corporations Act).

The Corporations Act requires that each person who wishes to be a continuing member agree to the terms of the constitution, including the guarantee amount.

The guarantee amount is the total amount that each member would be required to guarantee to the debts and liabilities of the company if ever wound up. The fixed guarantee amount of \$10 is contained at clause 5.1(b) of the proposed company constitution. An electronic copy of the proposed constitution may be easily accessed on the club's website or a physical copy obtained upon request from the club's secretary.

The Management Committee proposes to progress this transition in 2017.

Importantly, by signing this application for membership or membership renewal you are also agreeing to the terms of the constitution and \$10 guarantee if the members adopt the proposal by way of a special resolution at a general meeting to occur later in 2017.
