Amazing Tours Sydney 2018 Competition Terms & Conditions.

1. Information on how to enter and prizes form part of these Conditions of Entry. Entry into this promotion is deemed acceptance of these Conditions of Entry. Entry is via <http://amazingtours.sydney/competition> and/or Paper Entry Forms
2. Entry is free and open to Australian residents only, aged 18 years or older who complete, in full, the entry form available at <http://amazingtours.sydney/competition> and/or Paper Entry Forms provided during Coach Tours during the promotional period. Employees and immediate families of the Promoter and suppliers, providers and agencies associated with this promotion are ineligible to enter.
3. The promotion commences 13-January-2018 at 10am (AEDST, Australian Eastern Daylight Savings Time) and closes 16-December-2018 at 12pm (AEDST, Australian Eastern Daylight Savings Time).
