

ANNUAL MEMBERS EXHIBITION 2018

CONDITIONS OF ENTRY

1. The exhibition is open to Hervey Bay Art Society Inc (HBAS) members only.
2. **Entry Fees** must be included with the entry form and received by the due time and date. Payment can be made at the HBAS office by cash, or eftpos. For posted forms, Bank details are on the form for direct payment. Entry fees are not refundable.
3. **Number of Entries** is limited to a total of three per section per artist. Only works complying with the rules will be judged.
4. **Judging.** The decision of the Judge/s will be final and binding. The Management Committee will not enter into any discussion or correspondence concerning the decision of the Judge/s. If there are fewer than six entries in any section, or if, in the opinion of the Judge/s the entries have not reached an appropriate standard, a prize may not be awarded.
5. **Commission** on sales is 35% but volunteers rates will apply. Any paintings sold must remain on display until after the Opening Ceremony. All entries must be for sale.
6. **Copyright.** Each entry must be the original work completed by the artist within the last 12 months. No copies of paintings or paintings done with direct assistance in workshops will be acceptable.
7. **Exclusions.** An entry must not have won a prize in any previous exhibition (excluding HBAS monthly theme exhibitions).
8. **Presentation.** Large D rings must be securely attached for hanging. Works on stretched canvas must have all sides painted. The HBAS Committee reserves the right, with no explanation required, not to hang an entry if, in their opinion, it is deemed unsuitable or not properly presented.
9. **Labelling.** Each entry must be clearly labelled on the back with the artist's name, title of painting, medium, price and section.
12. **Size.** Each side of an entry must not exceed 120cm, including the frame.
13. **Title** of each entry must not exceed 25 characters.
14. **Freight, postage and insurance** costs and arrangements are the responsibility of the entrant. A pre-paid return freight voucher must accompany freighted entries. Posted entries must include stamps for return postage.
15. **Delivery and collection** of work must be within the times shown on the entry form.
16. **Unsold works** must be collected by the due time and date. Works not collected after one month become the property of the Hervey Bay Art Society and may be disposed of as the Management Committee sees fit.
9. **Disputes.**
Should any dispute arise for which no specific rule is laid down, then the decision of the HBAS Management Committee is final and binding on all parties.
10. **Liability.**
The entrant acknowledges that HBAS accepts no liability whatsoever for any loss of, or damage to, any exhibit whilst in its control. HBAS will exercise all reasonable care with the exhibits. Entrants should make their own arrangements to insure their entries against theft or accidental damage.
11. **Publicity Rights.**
The Management Committee of HBAS reserves the right to permit, without fee, the photographing or filming of any exhibit for use in any advertising medium to promote exhibitions or HBAS. Any further reproduction of any work must be in consultation with the artist.
