**TERMS AND CONDITIONS**

**1. General Conditions**

1.1 Eight Hour Blocks are meant for clients who want the venue for one ceremony only. If the venue is free, an additional eight hour slot will be given complimentary for décor and lighting.

1.2 24 hour blocks are given for clients who want the venue for two ceremonies, or have extensive décor and lighting. If the venue is free on the previous day of the booking, an additional eight hour slot will be given complimentary for décor and lighting.



1.3 Cleaning personnel for catering should be brought by the catering vendors. The caterers should provide a deposit of INR 10,000 which will be refunded after the event.

1.4 Drinking water should be brought by the catering vendor.

1.5 The client agrees to bear responsibility for any damage by the guests. The client agrees to compensate for the same.

1.6 No equipment should be plugged into the mains of Elements without prior permission. Failure to do so could result in tripping of our electricity supply, **and disruption to your event.**

1.7 Outside decorators, lighting vendors and furniture vendors are not allowed at Elements.

## **2 Tax structure**

2.1 The taxes applicable are 18% GST.

2.2 These are the currently applicable Government Taxes applicable. These are subject to change as per government notifications.

## **3 Deposit**

3.1 50% of the venue rental needs to be paid to secure the booking at Elements. This is non-refundable.

3.2 The remaining amount needs to be paid two months before the scheduled date of the event or immediately, whichever is earlier

3.3 Bookings can be transferred to another date at no additional charge, subject to availability of the venue.

3.4 Elements reserves the right of admission/entry into the venue and reserves the right of removing persons not conducting themselves properly. Elements and Sbharg Enterprises Private Limited do not take any responsibility for and shall not be liable for any loss of valuables/ belongings in the venue premises.

3.5 As per the requirement under the Income Tax Act, 1961, for settlement of bills in cash, it is mandatory for the payer to provide his/her Permanent Account Number.

3.6 Decision taken by the Elements Management or persons deputed by them, shall be final and binding on the parties.
